This program is designed to facilitate the housing needs of moderate and middle-income families. Residence at **Callaway Village** requires that applicants meet certain qualifying standards established by the government. This program is not connected with Section 8; however, housing choice voucher holders are encouraged to apply.

Residency at **Callaway Village** is limited to those families having moderate incomes. In **Fulton, MO** (Callaway County), the maximum allowable incomes (by family size) are as follows:
