TAX CREDIT PROGRAM INFORMATION SHEET CITY OF PORTER, TX (MONTGOMERY COUNTY)

Welcome to **Montgomery Pines Apartments**. Our community is operated under Section 42 of the LIHTC Program of the Internal Revenue Code. This program is designed to facilitate the housing needs of moderate and middle-income families. Residence at **Montgomery Pines Apartments** requires that applicants meet certain qualifying standards established by the government. This program is not connected with Section 8, however, housing choice voucher holders are encouraged to apply.

Residency at **Montgomery Pines Apartments** is limited to those families having moderate incomes. In (Montgomery County) **Porter, TX**, the maximum allowable incomes (by family size) are as follows:

In addition to standard wages, income includes monies received from many sources such as alimony, child support, pensions, and social security. A complete definition of income is detailed in the application. All information on income provided by applicants must be verified before occupancy. **This qualification and certification process must also be completed annually.** Failure to comply with recertification could result in ineligibility and may terminate your residency.

The rents at **Montgomery Pines Apartments** are limited by statute. Currently, the rents charged by bedroom are:

 The Maximum Occupancy for a (2) Bedroom Apartment shall be (5) persons.
 The Maximum Occupancy for a (3) Bedroom Apartment shall be (7) persons.
