## TAX CREDIT PROGRAM INFORMATION SHEET JACKSONVILLE, TX (CHEROKEE COUNTY)

Welcome to **Jacksonville Pines Apartments**. Our community is operated under Section 42 of the LIHTC Program of the Internal Revenue Code. This program is designed to facilitate the housing needs of moderate and middle-income families. Residence at **Jacksonville Pines Apartments** requires that applicants meet certain qualifying standards established by the government. This program is not connected with Section 8, however, housing choice voucher holders are encouraged to apply.

Residency at **Jacksonville Pines Apartments** is limited to those families having moderate incomes. In **Jacksonville, TX** (Cherokee County), the maximum allowable incomes (by family size) are as follows:

In addition to standard wages, income includes monies received from many sources such as alimony, child support, pensions, and social security. A complete definition of income is detailed in the application. All information on income provided by applicants must be verified before occupancy. This qualification and certification process must also be completed annually. Failure to comply with recertification could result in ineligibility.

The rents at **Jacksonville Pines Apartments** are limited by statute. Currently, the rents charged by bedroom are:

 The Maximum Occupancy for a (2) Bedroom Apartment shall be (5) persons.  
 The Maximum Occupancy for a (3) Bedroom Apartment shall be (7) persons.
