## TAX CREDIT PROGRAM INFORMATION SHEET ANKENY, IA (POLK COUNTY)

Welcome to **Villas at Meadow Springs Apartments**. Our community is operated under Section 42 of the LIHTC Program of the Internal Revenue Code. This program is designed to facilitate the housing needs of moderate and middle-income families. Residence at **Villas at Meadow Springs Apartments** requires that applicants meet certain qualifying standards established by the government. This program is not connected with Section 8, however, housing choice voucher holders are encouraged to apply. **Residency at Villas at Meadow Springs is limited to Households that the Head of Household is 55 years of age or older and additional household member are age 19 or over.**

Residency at **Villas at Meadow Springs Apartments** is limited to families having moderate incomes. In (Polk County) **Ankeny, IA** the maximum allowable incomes (by family size) are as follows:

In addition to standard wages, income includes monies received from many sources such as alimony, child support, pensions, and social security. A complete definition of income is detailed in the application. All information on income provided by applicants must be verified before occupancy. This qualification and certification process must also be completed annually. Failure to comply with recertification could result in ineligibility. If annual income is verified in subsequent years to be over the next qualifying income limit group, rent will be increased as applicable.

The rents at **Villas at Meadow Springs Apartments** are limited by statute. Currently, the rents charged by bedroom are:
